



Message Authentication

In all cases, it is expected that HTTP requests will be received using HTTPS with a suitable supported TLS version, and that all messages will be authenticated using the [OCLC WSKey standard](#).

Instead of requiring the identity of a staff user PPID or a Relying Party ID, the standard WSKey details (HMAC or Access Token as appropriate) are used to authenticate the partner ILL client. The WSKey must allow the partner client to use the WMS NCIP Service for the specified WMS library.

NCIP messages will be sent to a data-center specific URL that is handled by the WMS NCIP Service and can be routed using Institution IDs in the URIs. For example, a request to <https://91475.share.worldcat.org/ncip/circ-staff> will automatically direct the message to the U.S. Data Center for WMS.

Terminology

Throughout this article, the following terms are used:

- Requesting Institution - The Institution that is Requesting - or Borrowing - the resource.
- Supplying Institution - The Institution that is Supplying - or Lending - the resource. This is the Institution that owns the physical item.
- Circulation Desk - The terminal that accesses WMS Circulation.
- ILL Desk - The terminal that accesses the interlibrary loan or resource sharing system.
- Patron - The human being that is ultimately requesting the resource.
- Requesting Circ Staff - The human being that works on the Circulation Desk at the Requesting Institution.
- Requesting ILL Staff - The human being that works on the IL Desk at the Requesting Institution.
- Requesting Circulation - The Circulation System running at the Requesting Institution - ideally but not guaranteed to be WMS Circulation.
- Requesting ILL - The ILL System running at the Requesting Institution.
- Supplying Circ Staff - The human being that works on the Circulation Desk at the Supplying Institution.
- Supplying ILL Staff - The human being that works on the IL Desk at the Supplying Institution.
- Supplying Circulation - The Circulation System running at the Supplying Institution - ideally but not guaranteed to be WMS Circulation.
- Supplying ILL - The ILL System running at the Supplying Institution.
- Mandated Action - Many Circulation actions have policy restrictions, and if they are not met then the action can not be performed. A Mandated Action is where the action is considered to have already happened, and so the Circulation System is required to perform it regardless of policy.

Lending Library Workflow

The lender side workflow is the integration between the Supplying ILL system and the WMS Circulation System in the Supplying Library. Two actions are supported:

- **CheckOutItem** - used to indicate that an Item is now to be considered by the Supplying Circulation System as On Loan to the Requesting Institution
- **CheckInItem** - used to indicate that an Item is no longer to be considered by the Supplying Circulation System as On Loan to the Requesting Institution

Supported borrower schemes

The Borrower can be identified by any scheme/value pair listed in the "User Identification" section. Where possible, it should be the case that the Borrower that the Item is Checked Out to is actually the Requesting Institution. This means that it is identified by the "OCLC Institution Symbol" or "OCLC Institution Registry Id" options. This gives information to the Circulation System that a remote Institution is actually borrowing the item.

In some cases it might not be possible to do this, and the ILL System will instead be configured with a local Patron Barcode to use, which is typically a fake Patron used to represent ILL Loans. In this case it is acceptable to use the "Barcode" option instead.

Supported item schemes

The Item can only be identified by the scheme "http://www.niso.org/ncip/v1_0/imp1/schemes/visibleitemidentifiertype/visibleitemidentifiertype.scm" and value "Barcode". Any other values are invalid and will return an error.

Supported item schemes

The Item can be identified by any scheme/value pair listed in the "Item Identification" section. If identifying the Item by "ILL Request ID" then the item must have been checked out using the NCIP "CheckOutItem" message and providing the exact same value for the *RequestId/RequestIdentifierValue* field.

WMS prefers to identify the item by "ILL Request ID" to ensure that item handling is correct in WMS for pending loan requests, subsequent local loans, etc. For example, special handling is provided by WMS in the following scenario:

1. *CheckOutItem* is processed - marking the Item as On Loan
2. Item is shipped, used, and returned
3. *CheckInItem* is scheduled to be sent but is delayed for some reason.
4. Item is manually checked in by library staff
5. Item is checked out to a local patron
6. *CheckInItem* is processed – Item continues to be on loan to the local patron. WMS verifies only that the loan associated with the specified ILL request ID has been terminated.

Borrowing Library Workflow

The borrowing workflow is the integration between the Requesting ILL system and the WMS Circulation System in the Requesting Library. Two actions are supported:

- **LookUpUser** – used by the Requesting Library to authenticate and/or request details about a patron.
- **AcceptItem** - used to indicate that an Item has been received by the Requesting Library for a patron, and that the Circ system should represent this item as existing and being available to collect.
- **CheckInItem** - used to indicate that an Item is no longer in use by the Requesting Patron and that any loan it has should be terminated. This mostly exists to clean up in case the loan was not terminated by the Circulation desk correctly.
